

PRIVACY POLICY

1. This privacy policy ("Policy") must be read in conjunction with MakCorp's terms of use ("Terms"). Those terms defined in the Terms have the same meaning when used in this Policy.

Information

2. Except as otherwise provided in this Policy, MakCorp will not wilfully disclose any of your personal information you submit to the Website without first obtaining your approval, unless such disclosure is required to satisfy a legal obligation. By using the Website and accessing the Information, you agree to the collection and use of your information.

Website

3. MakCorp does not collect personal information about you or any person browsing the Website (together "the User") except where that information has been specifically provided by a User to MakCorp.
4. If a User provides any personal information to MakCorp via the Website or any other third party sites ("TPS") the User acknowledges they have read this Policy and consent to MakCorp using that personal information lawfully at its sole and absolute discretion, including but not limited to, the purposes of providing promotional and marketing materials by other means. The User must obtain the consent of any third person whose personal information you post to the Website.
5. Whenever the User uses the Website, the computer on which the web pages are stored (the Web server) needs to know the network address of the User's computer so that it can send the requested web pages to your Internet browser. The unique network address of your computer is called its "IP address," and is sent automatically each time you access any internet site. From a computer's IP address, it is possible to determine the general geographic location of that computer, but otherwise it is anonymous. Cookies are another technical measure MakCorp uses to serve you more efficiently when you visit the Website.
6. MakCorp may share general information about the use of the Website with advertisers, sponsors, content providers and other third parties. Generally MakCorp only discloses aggregate, anonymous information about Users and except where otherwise specifically required to do so, will not disclose any personally identifiable information to any third party without the User's approval.
7. You acknowledge on occasions it may be necessary for MakCorp to release personal information, including if MakCorp is required to do so to satisfy a legal obligation.
8. MakCorp may use the User's information to:
 - (a) properly operate the Website;
 - (b) identify you as the user of the Website and that you access the Information and to provide you with better use of the Website and access to view the Information;
 - (c) keep the User informed about the Website and the Information and any changes;
 - (d) participate in the process of any third party acquisition or potential acquisition of an interest in MakCorp or its assets;
 - (e) protect MakCorp's lawful interests or to fulfil a legal or regulatory obligation.

MakCorp may use external service providers or third parties to perform functions on MakCorp's behalf for example, using a mail house to facilitate communications with Users, processing credit card payments and providing customer service. These third parties may have access to the User's personal information and MakCorp will use all reasonable endeavours to ensure these third parties comply with the terms of this Policy.

9. For record-keeping purposes MakCorp may retain copies of emails sent to MakCorp. MakCorp does not anticipate the information in the emails received or sent will be disclosed to any third party without the permission of the sender, either express or implied, unless required or necessary as specified in the previous paragraph.
10. The Website may contain links to TPS that are not affiliated or associated with, or controlled by MakCorp. The User is aware these third party sites may be owned or developed by people over whom MakCorp has no control, and accordingly, MakCorp is not responsible for their privacy practices. This Policy applies only to those parts of the Website within MakCorp's control.
11. MakCorp makes no representations or warranties regarding how user data is stored or used on third party servers. You are responsible for checking the privacy policy of any third party website you visit which collects personal information about you and to use your discretion when providing such information.
